RNR™ therapy connects the relationship of neurotendinous organs *surrounding* all fascia, muscles & nerves.

When a person experiences pain, the pain signal may cause splinting, which is contraction of one group of muscles around another to immobilize them.

Splinting is a wonderful mechanism; however, when this signal does not "turn off", the healing process may be hindered.

This is called the "pain-spasm-pain" cycle; thus, creating a negative feedback loop. RNR™ therapy is *designed* to help the body remember to "turn off" this signal, so healing may be facilitated at a faster rate.



Page 26 SOFT-TISSUE MANIPULATION

Illustration of Muscle spindle, Golgi tendon organ, & nerve supply to & from these reporting stations.

EXTRAFUSAL NUSCLE FIBRE

Reporting Station: Golai Tendon Body **Detects load/overload** (fail safe/cut out). Measures stretch in series rather than parallel, therefore reflects tension.

Conveys Information to Muscle from CNS: Gamma Efferent Supplies muscle components at periphery of spindle.

FIBRES

Reporting Station: Annulospiral Fibres Detect small changes in length: monosynoptic connection: rapid, sometimes excessive discharge.

Reporting Station: Flower Spray Fibre Compensates for overreaction at primary receptor. Also relates to conscious activity.

> Conveys Information to Muscle from **CNS:** Alpha Efferent.

Muscle Spindle: Action of Gamma Efferents produces contraction of intrafusal muscle fibres which increase discharge rate & results in (extrafusal) muscle contraction. Ten to twelve intrafusal fibres lie parallel to muscles fibres. This is sensory organ responding to lengthening & shortening.




